ON 7/14/09 WJAR COMPLETED THIS CONSTRUCTION AND IMPLEMENTED ITS FINAL DTV FACILITY.</p> <p>DUE TO ADMINISTRATIVE OVERSIGHT, WJAR EXPERIENCED A DE MINIMIS FOUR PSA SHORTFALL DURING THE PRIME TIME HOURS IN THE SHORT TWO WEEKS IT WAS REQUIRED TO AIR CONSUMER EDUCATION NOTICES THIS QUARTER. THESE FOUR PSAS RAN AT 5:58:45 PM, 5:58:32 PM, 5:58:31 PM, AND 5:58:40 PM. IN ADDITION, WJAR RAN MORE THAN TWICE THE REQUIRED NUMBER OF CSTS DURING PRIME TIME HOURS AND NEARLY ONE AND A HALF TIMES THE REQUIRED TOTAL PSAS AND CSTS. DESPITE THIS ADMINISTRATIVE OVERSIGHT, MEDIA GENERAL BELIEVES THAT DURING THE THIRD QUARTER OF 2009 AND OVER THE LAST YEAR THE STATION HAS DEMONSTRATED AN EXTRAORDINARY COMMITMENT TO EDUCATING ITS VIEWERS ABOUT THE DTV TRANSITION.</p>
