## Incident Report

During my transport of McLeod to TIPD, he requested several times that I call Miley Cyrus. McLeod stated that he was a close friend and emailed her several times a day. McLeod stated that Cyrus` responses came in the form of "secret messages" on her television show directed only to him. McLeod stated that he had "thousands of pictures and letters to Miley on his computer." McLeod stated that he and Miley "were supposed to be together and we couldn`t stop it." McLeod stated that Miley had told him to drive to the beach to be with her. McLeod stated that he had left his vehicle (Buick Park Avenue) at "the baseball park where they hit golf balls." I recognized this description as Jaycee Park. Enroute to TIPD I drove past Jaycee Park and McLeod indicated that the Buick Park Avenue parked in the lot belonged to him. McLeod stated that he had "4 or 5 Miley stickers" on his dash. McLeod stated, "you guys can search my car, the keys are in it. All that`s in there is things Miley wanted me to bring."

McLeod continued to requested that Miley Cyrus be contacted. McLeod was very concerned that he be released so that he could "be with Miley, that`s what she wants!" McLeod was unable to post bond and refused to sign an arraignment waiver.

I transported McLeod to CCDC. During the trip, McLeod spoke extensively about his "relationship" with Cyrus. McLeod stated that he had met Cyrus a year and half ago. McLeod stated, "Our eyes met at her concert and we both knew. I walked straight thru security and up to her bus. Billy Ray was standing there. He shook my hand and said you`re the good man we`ve been praying for." McLeod stated he and Cyrus kept their relationship private because of the press. McLeod stated that he had proposed to Cyrus and she had accepted. McLeod stated, "we will always be together."

McLeod stated that he mailed "special presents" to Cyrus. McLeod stated that he had mailed Cyrus two diamond rings valued at \$2,000 and some "special private presents" that I would not understand. McLeod stated that Cyrus relayed requests for gifts to him thru her fan of the day posting on her web site. McLeod stated that a recent posting featured a fan in front of a sea wall. McLeod felt this posting was made by Cyrus to invite him to be with her at the beach.

McLeod exhibited hostility when the topic of other males in Cyrus` life was mentioned. McLeod stated, "Miley is only with the Jonas brother for the press." McLeod stated that he had dreamed about a special stage for Cyrus, but the Jonas brothers had stolen his idea. McLeod said that this special stage would be circular so Miley could always see him.

McLeod stated that he had been camping on Tybee for three or four days. He reported that he had observed Cyrus on her balcony. McLeod stated that Cyrus wanted him to be with her on the balcony. McLeod stated that Cyrus would look at him when no one else could see it. McLeod stated that Cyrus was looking at him when he was on the pier.

McLeod continued to request that I contact Cyrus. He insisted that she would tell me that he was "a good guy." McLeod stated that he was very close to Billy Ray, Noah, and Bridgett (or Brady). McLeod stated that he was not as close to Cyrus` mother Trish. McLeod stated that Trish was "linked to security". McLeod stated that some members of Cyrus` security team "walked with the devil."

McLeod stated that with the exception of Trish, the entire Cyrus family was very happy with his relationship with Miley. McLeod stated that the age difference was not important. McLeod stated, "Nobody will ever be able to keep us apart. We`re like one." McLeod stated that if I would just talk to Billy Ray everything would be cleared up. McLeod stated that he knew that soon we would be good friends and laugh about all of this. McLeod stated, "We`re going to be close buddies. I want you in the wedding. I know Miley will like you too, you have a good heart."

McLeod became very quiet when we arrived at CCDC. A GSP officer with a female prisoner was arriving at the

same time. McLeod became agitated that males and females were in the same facility. McLeod stated, "this isn't like the last place I was in." McLeod stated to the booking personnel that he was Miley Cyrus's boyfriend. McLeod requested that they contact Cyrus "before we waste all this time."
