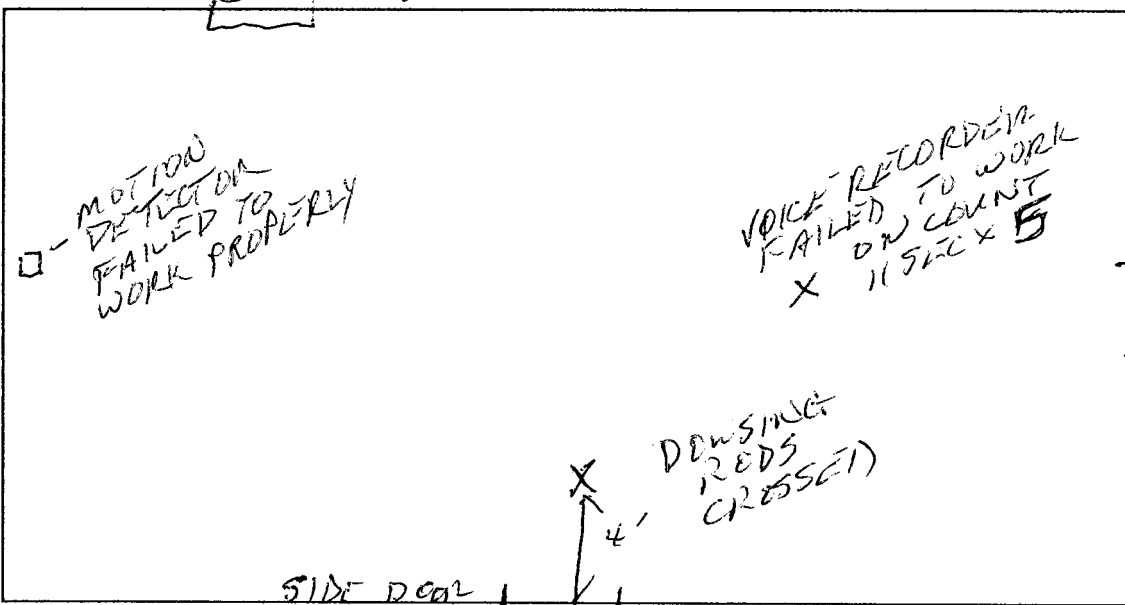

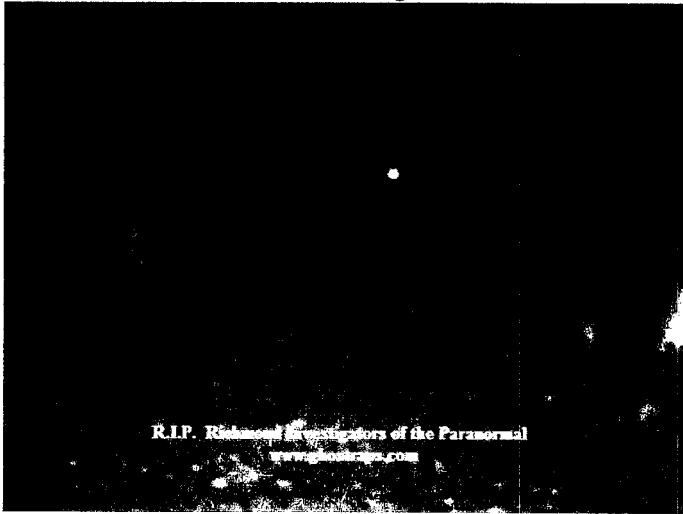

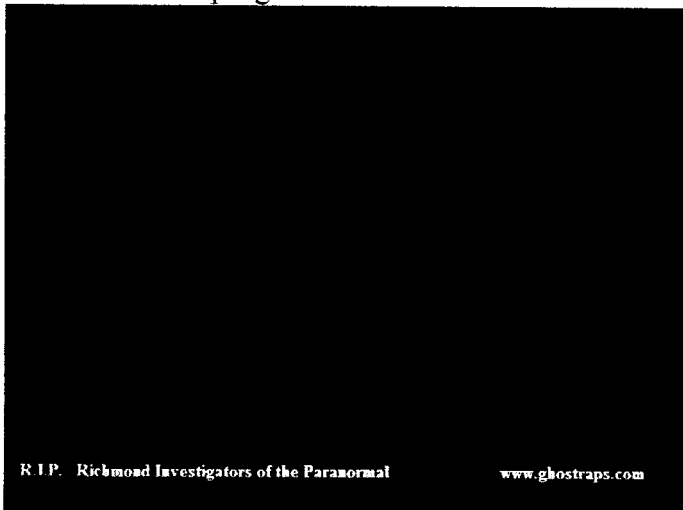
Notice the fiery orb. Is not a light as it is in front of a tree.

Investigative Report

Site: Historic Pole Green Church
Location: Mechanicsville, Va.

The investigation ran from: 10/7/08 2100 Hours
10/8/08 1230 Hours

The night was clear and cool: Temperature 59 Degrees F at the beginning of the investigation and dropped down to 50 Degrees F by the end of the investigation.
The temperature actually increased as we left the top of the hill and dropped down towards the creek.
Moon Phase 1st Quarter.

FINDINGS

Personal Experiences:

Two investigators upon arrival to the property began taking pictures with a still camera. The area when looking through the camera view finder showed nothing while the pictures were being taken.

However, looking beyond the camera from the area near the front of the parking lot looking back towards the old church site appeared to light up with thousands of little lights.

The best description would be if someone were shining a flashlight and several people took hands full of silver sparkles and through them into the air.

The area covered would approximate 100' wide and 50' deep.

We have seen this type of event on a few previous occasions; however, the wide area of coverage and the large number of little lights has not been witnessed up to this time.

Several pictures taken during this time shows a fairly large amount of orbs present during the time period mentioned above.

The number of orbs in the pictures, however, in no way represents the huge number of orbs that were seen with the naked eye.

Not one investigator felt strange or weird about or on the property.

No one felt threatened or fear while on the property.

No one had any difficulty while moving about on the property.

Night Vision Motion Camera:

Showed no results

Still Digital Photos:

There were over 10 pictures which show some form of an anomaly.

Pictures show: See Through Orbs, White Orbs, a Red Orb, 1 Mist Phenomenon, Unknown lights.

Still photos are included in the report.

Dowsing Rods:

The only place that our dowsing rods showed activity was exactly 4' within the church from middle of the side door. The rods crossed at that point no matter which direction the spot was approached.

EVP (Electronic Voice Phenomenon)

Using knowledge found during our research; Found no results

However, one voice recorder failed to record at what appeared to us a random point during one EVP Session. It turned off of its own accord. It would turn off on the count of 11 on 5 concurrent attempts to record a question and answer. The recorder would not work anymore and was put away for the night.

The next day the recorder worked fine and there was plenty of time left to record.

No theory as to why or how this occurred is hypothesized at this time.

EMF (Electromagnetic Field Device)

Showed no results.

The device showed no active electrical devices, nor did it show interaction during EVP Sessions.

Motion Sensor Light

Found no results.

However, near the end of our investigation the device did fail to work properly. It had functioned properly all night when one of us would walk in front of it up to that point.

No theory as to why or how this occurred or could occur is hypothesized at this time.

Other Techniques Used

Ball to roll for possible interaction with an entity found no results.

ASSESSMENT

Even though several unusual personal experiences did occur, and several unusual photos were taken not enough evidence and/or personal experiences would lead us to believe what we experienced on the night of this investigation would lead us to believe the property is haunted. There is, however, a probability that there is some form of paranormal activity taking place.

ADDENDUM REPORT TO REPORT OF 10/7/08

Site: Historic Pole Green Church

Location: Mechanicsville, Va.

The investigation ran from: 10/13/08 1915 Hours
10/13/08 2000 Hours

Atmospheric Conditions: Full Moon
Temp. 64 degrees F

On the above date and time returned to the above mentioned site to possibly debunk one particular photo and to see if we could reproduce an event that was definitely abnormal.

As mentioned in the original report there was the "Sparkle Affect" we mentioned upon arrival to the property.

To reiterate...upon our arrival we began taking pictures in the parking lot. On the screen of the camera showed little other than a few orbs. However, when looking across the parking lot towards the woods and church there were what appeared to be thousands of little lights.

We discussed this in great detail and it was decided it was probably paranormal in nature, but could possibly have been a result of moisture in the air as there was dew forming.

Upon returning I attempted to recreate the affect and was able to do so. The same "Sparkle Affect" did occur just as it did on our first visit of 10/7/08. However, there were two differences. One, the night was much warmer. Two, there was no moisture in the air.

Therefore, under two different environment conditions we were able to witness a similar paranormal event.

There is one other difference. The first event (10/7/09) and the second event (10/13/08) were witnessed by 2 different investigators along with the founder of our group.

And the photos of 10/13/08 are even more interesting that those of 10/7/08.

These are included for your viewing. We still have no explanation for why these photos turned out as they did.

Another difference was the atmospheric temperatures of the two different nights. The first night (10/7/08) was cold; the night of (10/13/08) was much warmer. On 10/13/08 myself and the other investigator experienced cold spots on two different areas of the property.

The first area was approximately 25' to the right front of the church on the path near the large oak tree. The second area was in the parking lot in the corner nearest the flag pole.

The first area mentioned caused extreme goose pimples to form on both of our arms. I was wearing short sleeves and the other investigator was wearing long sleeves. However, both us experienced the same affect to the point the goose flesh could be felt by the other person.

In the second area we could extend our arms one arm would be extremely cold while the other arm would be warm. The same coolness extended up to and included the sides of our faces depending on how far we would move into the cool area.

This cold spot lasted approximately five minutes and it moved through the fence and onto The grassy area towards the road (Rural Point Rd.) at which point we could follow it no further.

Pictures were taken but nothing in the photos showed any anomaly present in the environment.

Impression

We still cannot say the site is haunted, however, we strongly believe something paranormal is happening there.
