Report Narrative: On Friday, October 16, 2009, I, Officer Calderwood responded to the incident location for a "Code: Red". While in route, it was learned that the victim, was in need of assistance. Upon arrival, the victim was located with several puncture marks on the back of his uniform shirt. The suspect was located in the second office of the building. The suspect was being cared for by several personnel. CPR was being administered to the suspect along with the assistance of the schools AED. Crime scene tape was utilized around the office area and the front of the building. Witnesses were given voluntary statement forms and removed from the scene. EMS and fire personnel assisted with the suspect. The victim was moved to a separate location. It was learned that the victim had disarmed the suspect with one knife and a second knife still in the possession of the suspect. The victim had to shoot the suspect several times. Photos were taken and both the victim and suspect were transported to Conway Medical Center. I was eventually relieved by SLED and Crime Scene.
