Report Narrative: ON 1-3-09 AT APPROX 1513 WE RECEIVED A 911 CALL FROM THE COMPLAINANT WHO STATED HE COULD SEE TWO INDIVIDUALS LYING ON THE FLOOR INSIDE THE RESIDENCE AND THEY WERE NOT MOVING. BEFORE I ARRIVED ON SCENE THE COMPLAINANT FORCED ENTRY THROUGH THE FRONT DOOR TO GET INSIDE. WHEN REPORTING OFFICER ARRIVED ON SCENE THE COMPLAINANT WAS STANDING IN THE FRONT YARD TO FLAG ME DOWN. REPORTING OFFICER LOCATED BOTH VICTIMS IN THE RESIDENCE ON THE GROUND IN THE LIVING ROOM. BOTH VICTIMS HAD LARGE POOLS OF BLOOD ON THE FLOOR AROUND THE HEAD AREA. I OBSERVED A BLACK IN COLOR GLOCK PISTOL LYING ON THE FLOOR NEARBY. I ALSO OBSERVED SEVERAL SPENT SHELL CASINGS AROUND THE AREA OF BOTH VICTIMS. THEIR WAS A CHAIR BROKEN AND LYING OVER NEAR BOTH VICTIMS. REPORTING OFFICER SECURED THE CRIME SCENE AND SGT BONNER ARRIVED ON SCENE SHORTLY AFTER I DID. MYSELF AND SGT BONNER DID CLEAR THE RESIDENCE FOR POTENTIAL SUSPECTS AND FOUND NOTHING. THE CRIME SCENE WAS TURNED OVER TO HORRY COUNTY DETECTIVES AND CRIME SCENE. THE COMPLAINANT IS THE FATHER OF VICTIM #2.
