responded and then was informed to contact Deputy's. Deputy Hill then asked Ronald Pride to write out a statement concerning the events and Ronald Pride agreed. Deputy Hill then talk with the suspect [redacted] who stated that his glass storm door was broken out on his house sometime, ON 7-5-08 AND THAT he know the person or person's that were in the car that hit Ronald Pride out was the one's that did it but that he could not prove it. He stated that the person's that hit Ronald Pride out then fingered him in a disrespectful manner. [redacted] then advised Ronald Pride to tell his "family" to stop messing with him. At which point words of profanity's were exchanged. [redacted] stated to Deputy Hill that Ronald Pride went inside his residence first and yes he did go inside and retrieve his pistol but that he did not point it but that he did have it for his protection. [redacted] stated to Deputy Hill that he had, had problems with his neighbors before. Deputy Hill then attempted to talk to the surrounding neighbors who stated they heard "bussing" but nothing else. Deputy Hill then spoke with Officer Bailey the first on scene and Officer Bailey stated he did not see a gun, but that Ronald was upset upon his arrival. Deputy Hill was informed of a third party who was present during the altercation, but was unable to be located. Deputy Hill informed both [redacted] and Ronald Pride a report would be written and given to Investigators.
