LOCATED AND STOPPED THE VEHICLE ON WAYNE ST., A FEW BLOCKS FROM THE CEMETARY. I MADE CONTACT WITH THE OCCUPANTS OF THE VEHICLE, THE DRIVER WHO WAS IDENTIFIED AS ROLAND CORNING, AND THE PASSENGER A 18 YEAR OLD EMPLOYEE OF PLATINUM PLUS GENTLEMENS CLUB. DURING THE COURSE OF A FIELD INTERVIEW OF BOTH SUBJECTS THE SUBJECTS GAVE CONFLICTING STATEMENTS AS TO WHY THEY WERE AT THE LOCATION, AND TO THERE RELATIONSHIP. DUE TO THE DISRCEPANCY IN THE STATEMENTS I ATTEMPTED TO INTERVIEW MR. CORNING FURTHER WHEN HE ADVISED ME THAT HE WAS AN ATTORNEY, AND THEN HE PRODUCED A STATE ATTORNEY GENERAL'S BADGE. AT THAT POINT I ASKED IF THERE WAS ANYTHING ILLEGAL IN THE VEHICLE, WHICH HE STATED NO AND GAVE CONSENT TO SEARCH. A SEARCH OF THE VEHICLE REVEALED A AMBER UNMARKED PILL BOTTLE CONTAINING HALF A VIAGRA, AND TWO VIBRATING PENIS RINGS. MR. CORNING STATED THAT HE HAS A PRESCRIPTION FOR THE DRUG, ANDTHAT THE OTHER ITEMS WERE ALWAYS IN THE VEHICLE " JUST IN CASE". AT THAT POINT I DECIDED TO RELEASE THE FEMALE WHO STATED THAT HER VEHICLE WAS AROUND THE CORNER WHERE MR. CORNING MET HER. MOMENTS LATER I RELEASED MR. CORNING WHO STATED HE WAS ON HIS LUNCH BREAK.
