C. Supplemental Report of Investigation

a. Interview of Emily Jane Crabtree

Emily Crabtree was interviewed telephonically on June 13, 2008. Ms. Crabtree was then incarcerated in the Abingdon Regional Jail, Abingdon, Virginia. Shirley Forrester, a victim/witness advocate in Tazewell, Virginia also participated in the telephonic interview at the request of Ms. Crabtree. Ms. Forrester arranged the conference call for the interview.

Ms. Crabtree said the Respondent was appointed to represent her in a child custody issue at the Juvenile and Domestic Relations Court (J&DR) of Russell County, Lebanon, Virginia. Ms. Crabtree said she met the Respondent about 1 ½ to 2 years ago when the custody issue arose. Ms. Crabtree said the custody issue concerned her daughter,

Ms. Crabtree opined she might have dressed provocatively, because she wanted to look nice for court. Ms. Crabtree said she and the Respondent were talking and flirting in the courtroom hallway, when the Respondent suggested they go into a nearby witness room. Ms. Crabtree said the discussion between the Respondent and herself had become somewhat provocative and sexual.

Ms. Crabtree said that when she and the Respondent entered the room, they shut the door. Ms. Crabtree said there was no kissing, but she squatted on her ankles in front of the Respondent, unzipped the Respondent's pants, pulled out his penis, aroused him, and

then performed fellatio on the Respondent. Ms. Crabtree said that after a period of time, the Respondent ejaculated into her mouth.

Ms. Crabtree said she then ran out of the room and into a nearby bathroom. Ms. Crabtree said she then spit the Respondent's ejaculate out of her mouth. Ms. Crabtree said the Respondent did not physically force her to perform fellatio on him. Ms. Crabtree opined that she blamed herself for being so provocative. Ms. Crabtree said that she performed fellatio on the Respondent because she needed him to represent him at the hearing, and was afraid he might not represent her if she did not perform fellatio on him.

Ms. Crabtree opined that the Respondent still represents her, and she is scheduled for a hearing on a custody matter on August 8, 2008.
