Informed by Case managers, Cindy Hale and Barbara Smith that previous pt, [REDACTED], made accusation of sexual abuse occurring while she was a patient at NHC. This SW requested that case manager inform family of request of meeting. S. [REDACTED] 4-6-07

5:15pm

Met with physician, case manager and family of [REDACTED]. DTR of pt, [REDACTED] stated that pt having a great fear of getting into bed. DTR passed pt on 4-4-07 to tell her what was wrong. Pt confided to dtr that a CNA came into her room and sexually abused her. She states pt was able to give a description. Mrs. [REDACTED] states that she called CTR and received info that the only male CNAs in evenings were Agency staff. Mrs. [REDACTED] then called Agency and represented herself as needing a sitter when her Mom returned home and that she knew of an Agency staff member but did not know his name. Mrs. Snow gave the Agency the description that pt had given her. The Agency gave the name of [REDACTED]. S. [REDACTED] 4-6-07

5:45

This SW requested to meet w/ pt, family agreed. Her daughters and granddaughter were present



Introduced myself to patient and explained that I would need to hear from her what happened. Pt stated "He came in to my room and 'handled me'. SW asked what she meant by "handled". Stated "When he first came in the room he "pushed" around the bed. Again, asked what she meant. She made the motion of leaning toward the bed and stated he was leaning in to me and I could". Pt stopped talking - tearing up. SW asked "And you could feel him" Pt stated "Yes". SW asked pt what time this was. Pt stated that it was night time that she was asleep when he came in. SW asked what happened next. "He tried to push it in" SW asked "Did his privates penetrate your vagina?" Pt did not understand question. SW re-phrased - Did he put his private in to your vagina? Pt replied "He tried" "He kept trying to force it" SW asked if he was dressed or exposed himself. Stated that she could not remember that. "He crawled up in the bed on top of me and kept trying to force it". Asked if she could remember what he looked like. Stated he was a big man w/ lots of tattoos. "I never forget him" "I never saw him after that" "This is the most embarrassing thing I have been so scared" "I never thought this would happen to me" "I'm not lying" "I will swear on the Bible" →

JW explained that an investigation would need to be completed, stated that a man from APS would come. Pt thought I would be bringing the CNA in question, became very upset. Explained that it would be APS + police and calmed pt. and ensured her that CNA would not be present.

4/6/07 met with daughter, [redacted] this Am. explained steps made thus far. Asked if family would need to present if police - APS question pt the date. Family stated there only request is for this SW to be present with patient.
